

PRIVACY POLICY

BACKGROUND:

This Policy applies as between you, the User of this Website and Infobee Directory LTD the owner and provider of this Website. This Policy applies to our use of any and all Data collected by us in relation to your use of the Website.

1. Definitions and Interpretation

In this Policy the following terms shall have the following meanings:

"Data" means collectively all information that you submit to the infobee Directory LTD

via the Website. This definition shall, where applicable, incorporate the

definitions provided in the Data Protection Act 1998;

"Infobee Directory" means Infobee Directory LTD of 249 Cranbrook rd. Ilford. Essex IG1 4TG;

"User" means any third party that accesses the Website and is not employed by

2. Scope of this Policy

- 3.11 operating system (automatically collected);
- 3.12 a list of URLs starting with a referring site, your activity on this Website, and the site you exit to (automatically collected); and
- 3.13 information about your business or products you like to sell

4. Our Use of Data

- 4.1 Any personal Data you submit will be retained by Infobee Directory LTD for unlimited time.
- 4.2 Unless we are obliged or permitted by law to do so, and subject to Clause 5, the data you choose to keep undisclosed will not be disclosed to third parties. This does not include our affiliates and / or other companies within our group.

- 4.4.2 improvement of our products / services;
- 4.4.3 transmission by email of promotional materials that may be of interest to you;
